Implementation Status and Key Decisions

The overall progress in meeting the project development objective and implementation progress is rated as Satisfactory, the Government has made steady progress to finalize all activities under the project. Active dialogue with communities has been done to resolve issues at some selected school sites. However, a few sites have had to be abandoned before completion. The rating for both the PDO and implementation progress were upgraded to highly satisfactory and satisfactory, as government has been able to significantly improve the pace of project progress and finalize the teacher recruitment for the new schools, thereby significantly improving the enrollment in schools. Monitoring of existing schools and an oversight by the school management comittees has increased children's participation in existing schools.

The success of the test based teacher recruitment has resulted in a province wide adoption of testing for teacher recruitment, this is a very important reform to ensure entry of qualified teachers in the system on merit.

The PMU has successfully monitored the construction activities and uploaded the progress on its website for wider sharing.

This is because of a) 7 schools out of 150 not becoming functional because of community conflict or security issues. Some schools only have a single teacher at this time as some teachers could not join due to personal reasons. However, all 143 schools have at least 1 teacher at the minimum.
